## **LOCATION & DESCRIPTION**

## **USE / PLANNING**

The industrial units are suitable for B1, B2 and B8 which includes light/general industry, wholesale warehouse and distribution centres.

## **LEASE**

## **RENT**

The Council is seeking a rental of £22,000 per annum, payable monthly in advance by direct debit only. A deposit of one quarters rent will be required, in some circumstances two quarters, which will be returned on vacation of the unit subject to all terms and conditions being complied with.

## **REPAIRS**

The tenant will be responsible for the maintenance of the whole of the premises excluding subsidence.

- Insurance: The whole building is insured by the landlord. The tenant reimburses the landlord an appropriate share of the annual premium.
- Service Charge: The annual charge is currently set at £375 per annum
